CONSIGNOR AGREEMENT

1. Agreement allowing RUBY ROSETTE, INC. to market your furniture and home decor on our social media sites, online store, and showroom
2. The Consignor's merchandise must be clean, not torn, not stained, not broken
3. RUBY ROSETTE reserves the right to refuse any merchandise for any reason
4. RUBY ROSETTE will do its best to protect your merchandise, however, we are not liable for damage or loss due to accidents, theft or fire. Merchandise shall remain under the coverage of Consignor's home insurance policy
5. **All items are consigned for a 6-month term from the date the consigned items arrive in RUBY ROSETTE showroom**
6. **You may pick up your items at any time during the 180 days. Schedule a pickup time with us before arriving**
7. All merchandise will be offered for sale at a price set by RUBY ROSETTE and discounted as defined below:
 - **Day 1-60:** the merchandise is offered for sale on RubyRosette.com
 - **Day 61-80:** the merchandise price will be reduced by 20%
 - **Day 81-120:** the merchandise price will be reduced by 30%
 - **Day 121-180:** the merchandise price will be reduced by 50%
 - **Day 181:** if items remain unsold, the Consignor (you) will have five (5) calendar days to remove the merchandise from Ruby Rosette's showroom at Consignor's expense
 - **Day 181:** If the Consignor fails to pick up the merchandise by end of business day, the merchandise becomes the property of Ruby Rosette, Inc.
8. The Consignor will receive 70% of the selling price (not including applicable sales tax)
9. Consignor will receive a check or PayPal payment once each month for previous month's sales
10. Make note of expiration date of your items. You may contact RUBY ROSETTE to see if items have been sold
11. Please note: RUBY ROSETTE DO NOT CALL YOU WHEN YOUR ITEMS SELL or REMIND YOU OF EXPIRATION DATES
